b) <u>Is the methodology of the green barrier assessment robust and has it been applied consistently?</u>

Savills Response

Savills consider that the methodology of the Green Barrier Assessment used to support Policy EN11 (Green Barriers) of the Flintshire Local Development Plan 2015 ±2030 is flawed as it does not take account of the significant impacts that the proposed developments featured in Policy PC10 (New Transport Schemes) will have on the Green Barrier. As a result, large areas of land, such as GEN4(4), have been retained as Green Barrier by the assessment despite being sustainably located on the edge of a settlement and being partially safeguarded for <sup>3</sup> 1 H Z 7 U D Q V S R U W. 6 F K H P H V ′




Appendix 1: Proposed Area of Safeguarding for Roadside Services
