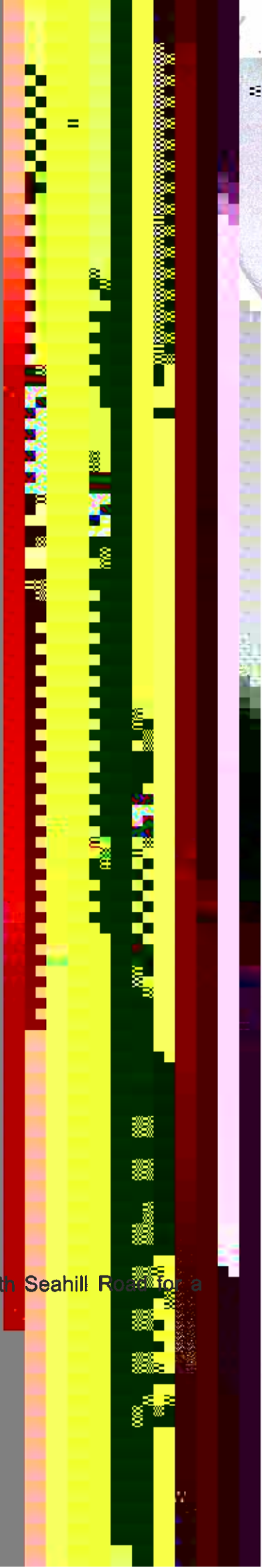

The Flintshire County Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the “Act of 1984”) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
2. The Flintshire County (Sealand Road, Seahill Road and Old Sealand Road, Sealand) (Speed Limit) Order 2015 shall have effect as though the third Schedule to that Order shall be deleted and replaced with:-

**SCHEDULE 3
50mph Speed Limit**

A548 Sealand Road

From a point 150 metres east of its junction with Manor Road, in an easterly direction to a point 100 metres north west of its junction with Western Avenue, Blacon.

3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the XX 202X and may be cited as The Flintshire County Council (Sealand Road, Seahill Road and Old Sealand Road, Sealand) (Speed Limit) (Amendment) Order 202x
